### **Work Experience – Monday 23<sup>rd</sup> May – Friday 27<sup>th</sup> May 2022**

As you may already know, our Year 10 students undertake a Work Experience Placement during this academic year. Attached are letters to you and your child with details of the scheme. There is also a letter to be passed on to potential Work Experience employers with a Placement form. Your child will be bringing home copies of these and further copies can be found on the school website.

The only restrictions on where your child can undertake work experience is that the company must have Employer and Public Liability Insurance cover, a health and safety check is completed and the placement is within the UK. The school will arrange all health and safety checks.

With all work placement requests within the South West, to ensure a health and safety check can take place, we must receive signed and completed work experience forms by **21<sup>st</sup> March 2022**. After this date, health and safety checks are unlikely to be completed, will incur a fee, and the school may not be able to validate the placement.

If students wish to undertake work experience with a company outside of the South West but within the UK, we are happy to help arrange this where we can but it is vital that these requests are arranged as soon as possible so that we can ensure all necessary checks can be completed in time. **Please note**, with these requests a charge will be levied in respect of out of area health & safety checks, in line with the Charging & Remission Policy, and these will be payable by the parent. Sadly, we are unable to help with transport or accommodation costs. The deadline to return the required paperwork for these requests is **7<sup>th</sup> February 2022**.

Before returning the completed Placement form to the Academy, please could you ensure that the employer has **signed the form on both sides**. The Health & Safety Section on the back also needs to be completed and signed by you as the parent/carer.
